Program Procedures & Requirements:

- Limited to one rebate per appliance type per calendar year.
- Appliance must be installed at Members home.
- Appliances must be certified as Energy Star to be eligible.
- Members are responsible for proper disposal of preowned appliances.
- All applications must be complete and include attachments.
- All projects must comply with applicable federal, state, and local laws and build codes.
- After all program requirements are met, a rebate in the form of a bill credit will be issued to the member's account. Please allow 8 to 10 weeks after receipt of all documents for the program bill credit to appear.

Installation Verification:

Warren Electric cooperative reserves the right to inspect the member's home for installation of materials listed on this application and to verify that installation meets program guidelines. The member may not receive the rebate if Warren Electric Cooperative cannot verify the information provided on the application form.

Member Certification and Confirmation:

Under penalty of perjury, I certify that the appliance for which I am claiming a rebate is a qualifying Energy Star rated appliance, and that it has been installed at the address listed on this Application which is a valid Warren Electric Cooperative account. Rebates are available only for the purchase of new Energy Star rated appliances purchased on or after June 1, 2018. The appliance must be installed where electricity is supplied by Warren Electric Cooperative. Rebates submittal must follow the guidelines listed in this Application. Warren Electric Cooperative is not responsible for inaccurate information supplied by appliance dealers. Rebates will be issued only for appliances listed as Energy Star rated. Energy Star occasionally removes appliances from qualifying lists, and Warren Electric Cooperative will not rebate appliances that have been delisted as of the purchase date or are mislabeled as Energy Star. To verify Energy Star status, visit www.energystar.gov. Rebate program is subject to change or cancellation without notice.
